

IMPORTANT RESOLUTIONS AND DECISIONS BY MCPC

1. UPGRADATION OF QUALIFIED POTENTIAL TRAINERS AND TRAINERS FROM THE 05 DAYS INTENSIVE TRAINING PROGRAMME TO THE NEXT CATEGORY:

Potential Trainers and Trainers of the MCPC with 3 & 4 Grading respectively from the 05 Days Intensive Training Programme shall be graduated to the next category (eg: Potential Trainer to Trainer in case of Potential Trainer and Trainer to Senior Trainer in case of Trainer) on completion of Five (05) & Three (03) 40hrs Mediation Training Programmes under the aegis of the MCPC respectively.

(Resolution adopted in the Committee Meeting of the MCPC held on 1st February, 2023)

2. OUT OF POCKET EXPENSES/HONORARIUM TO THE POTENTIAL TRAINERS WHO ARE YET TO UNDERGO 05 DAYS INTENSIVE TRAINING PROGRAMME:

Potential Trainers of the MCPC who are yet to undergo 05 Days Intensive Training Programme and are deputed for conducting Mediation Training Programmes under the aegis of the MCPC shall be paid Honorarium/Out of Pocket Expenses as per the below given rates by the Host State that proposes for the Training Programme:

**Honorarium to the Potential Trainers - Rs. 7,000/- per day
who are Advocates of actual training**

**Out of Pocket Expenses to the - Rs. 5,000/- per day
Potential Trainers who are of actual training
Judicial Officers**

3. TRAVEL ARRANGEMENTS OF THE POTENTIAL TRAINERS DEPUTED TO CONDUCT MEDIATION TRAINING PROGRAMMES:

Travel arrangements of Potential Trainers of the MCPC deputed for conducting Mediation Training Programme shall be done by the Host State that proposes for the Training Programme.

4. REVISION OF HONORARIA PAID TO THE MEDIATORS:

As resolved by the committee of MCPC, the following rates of honoraria shall be payable to the Mediators throughout the country:

S.No.	Nature of Case	Honorarium
A.	On settlement through Mediation	Rs. 5,000/- per case.

B.	Connected Cases	Rs. 1,000/- per case subject to a maximum of Rs. 3,000/- (regardless of the number of connected cases)
C.	In case of no settlement (in case the party fail to arrive at an amicable settlement despite three effective hearings)	Rs. 2,500/-

5. PAYMENT OF HONORARIA TO THE QUALIFIED POTENTIAL TRAINERS:

As resolved by the committee of MCPC, the following honorarium/out of pocket expenses shall be paid to the qualified potential trainers (with 3 grading from the 05 Days Intensive Training Programmes under the aegis of MCPC) by the respective State Mediation Centres/ Legal Services Authority to which they belong:

Qualified Potential Trainers **who are Advocates** - Rs. 7,000/- for each day of actual training

Qualified Potential Trainers **who are Judicial Officers** - Rs. 5,000/- for each day of actual training

6. HONORARIA PAID TO THE SENIOR TRAINERS/TRAINERS FOR IMPARTING ONLINE MEDIATION TRAININGS UNDER THE AEGIS OF MCPC:

As resolved by the committee of MCPC, rate of Honorarium paid to the Senior Trainers/Trainers for conducting and imparting online Mediation Training Programme shall remain the same as earlier irrespective of increase in the number of days of online training.

Honorarium for Senior Trainers/Trainers - 40hrs who are not Judicial Officers - Rs. 50,000/- (for online MTP of 08 Days)
Rs. 30,000/- (for online 20hrs Refresher Programme of 05Days)

Out of Pocket Expenses to Judicial - Officers - Rs. 35,000/- (for online 40hrs MTP of 08 Days)
Rs. 21,000/- (for online 20hrs Refresher Programme of 05Days)

7. ACCREDITATION TO NON MCPC MEDIATORS/ORGANIZATIONS:

No accreditation from MCPC shall be granted to the Mediators/ Organizations who have neither undergone nor conducted any of the MCPC approved mediation training.

8. PRE-LITIGATION MEDIATION:

Pre-litigation Mediation be conducted only in nearby mediation centres by Trained Mediators rather than such mediation being conducted at police stations.

(Resolution adopted in the committee meeting of MCPC held on 30th April, 2019)

9. CRITERIA FOR ADVANCED COURSE (CAPSULE COURSE):

It was resolved that for qualification for undergoing Advanced Course (Capsule Course) the criteria be brought down to total of 25 mediations as against the previous count 50 successful mediations, irrespective of successful or unsuccessful mediations.

10. HONORARIA PAID TO THE SENIOR TRAINERS/TRAINERS FOR CONDUCTING AND IMPARTING MEDIATION TRAININGS UNDER THE AEGIS OF MCPC:

Honorarium paid to the Senior Trainers/Trainers, who are not Judicial Officers and out of pocket expenses to Judicial Officer shall be:

Honorarium for Senior Trainers/Trainers - Rs. 10,000/- (for each day of who are not Judicial Officer actual training)

Out of Pocket expenses to Judicial Officer - Rs. 7,000- (for each day of actual training)

(Resolution adopted in the committee meeting of MCPC held on 9th January, 2019)

11. ACCREDITATION TO MEDIATORS:

Only those persons, who have completed at least 10 mediations resulting in settlement and at least 20 mediations in all, shall be eligible to be accredited as qualified mediators.

(Resolution adopted in the committee meeting of MCPC held on 7th December, 2012)

12. MEDIATION CENTRES AT STATE LEVEL:

One full fledged mediation centre with all necessary infrastructure shall be established in each State.

(Resolution adopted in the committee meeting of MCPC held on 16th March, 2010)

13. 40 HRS MEDIATION TRAINING PROGRAMME (MTP):

Training of Mediation is absolutely necessary for mediators, duration of which will be 40 hours plus 10 actual mediations.

(Resolution adopted in the committee meeting of MCPC held on 15th November, 2007)
